## **BASIC PESTICIDE TRAINING CLASS**

This course qualifies as a "Basic Training Course" as a prerequisite for Core Certification and/or Initial Operator Licensing. Senior Inspectors of the Pesticide Control Program will teach the class. Topics to be covered are: proper licensing for applicators and businesses, record keeping, proper maintenance of pesticide storage areas, service vehicle, operators and how to comply with the current notification requirements. Remember that before you enter into business for yourself, you must first license that business with the Pesticide Control Program, and if you plan on getting licensed, you need to attend a BASIC TRAINING COURSE. The Pesticide Control Program is offering a program designed to teach you everything you need to avoid costly penalties for not properly following the regulations.

Classes will be held at our main offices at 401 East State Street, Trenton, NJ, in the Public Hearing Room. Classes run approximately 4 hours (9:00 am to 1:00 pm). The format will mimic a Routine Applicator Business Inspection (this is the inspection we perform with all applicators and businesses at one time or another). All fully certified applicators in attendance will receive 4 units of recertification credit towards Core and *No Fee Will Be Charged For The Class!* If you wish to attend a class, please read and fill out the information below and return it to the Pesticide Control Program, either by mail, fax or e-mail. **NOTE: This course will be offered to you on a one-time per applicator/business basis. If you do not show up for your scheduled class, you must contact Stephen Bross (609)984-6953 of the Pesticide Control Program immediately to reschedule.**
